Writing Assignment #1: Personal Reflections on Sexual Learning

WRITING ASSIGNMENT OBJECTIVES:

- Critically evaluate how a topic pertaining to human sexuality relates to your life
- Fulfill the Core Competency requirement for writing in the General Education curriculum.

PROMPT

Write a reflective essay that addresses the following points.

- What did your parents teach you about sex? How old were you? How did you feel about these conversations as they were happening? How do you feel now about what your parents taught you? Note: for the purposes of this assignment, "sex" includes reproductive anatomy and puberty, as well sexuality/sexual behavior.
- What did you learn in school about sex? How old were you? How did you feel about this then? Now?
- In what areas (if any) was your sex education exceptionally good (consider what you were taught by both parents and schools)? Do you feel there were any gaps in your education? What would you have liked to have learned that you did not? What should you have learned at a different age (earlier or later)?
- In 1-2 sentences, explain what the goal of school sex education should be.
- Describe the characteristics of an "ideal" school sex education program. What should schools teach about these topics in elementary school, middle school, and high school? Be as specific as possible about what should be taught at what ages.
- What topics, if any, do you think schools should leave for parents to discuss at home? Explain your reasoning.

ASSIGNMENT INSTRUCTIONS AND FORMATTING

- Your submission needs to be double-spaced and between 2-3 pages (not including citations and references). Use one-inch margins and 12 point Times New Roman font. No cover page or heading is required.
- This is assignment is mostly reflection on your personal experience, any therefore may not require citations/references. If you decide to include information from a source, it must be properly cited.

- Your submission must be organized as an essay, not a series of questions and answers.
- The entire submission should be written in your own words. Direct quotes are not permitted. If you include information from a source, it must be properly paraphrased.
- Be sure to define any technical terms that you use in your own words. Your paper should be written so the average person can understand it.
- Use the appropriate academic terms for body structures, not slang.
- Please review the rubric before submitting your assignment
